#### DISCHARGE AGREEMENT

between '

- (1) SCOTTISH WATER, a body corporate established under section 20 of the Water Industry (Scotland) Act 2002 and having its principal office at Castle House, 6 Castle Drive, Carnegie Campus, Dunfermline, KY11 8GG (hereinafter referred to as "Scottish Water") (who and whose successors in ownership of the Lands aftermentioned are all together hereinafter referred to as "the Land Owners") and
- (2) NETWORK RAIL INFRASTRUCTURE LIMITED, incorporated under the Companies Acts (Company Number 2904587) and having its registered office at 1 Eversholt Street, London, NW1 2DN (who and whose successors in the ownership of Network Rail's Land aftermentioned are hereinafter referred to as "Network Rail")

#### WHEREAS:

- A. The Land Owners are owner of ALL and WHOLE the lands ("the Lands") described in Part 1 of the Schedule annexed and signed as relative hereto ("the Schedule") and the Land Owners as such proprietors, have or may have the benefit of rights to use the Level Crossing as aftermentioned;
- B. Network Rail is owner of ALL and WHOLE Network Rail's Land more particularly described in Part 2 of the Schedule, all as Network Rail's Land incorporates Bogton Sewage Works Level Crossing, Forres ("the Level Crossing") at the location coloured red on Plan 1 annexed and signed as relative hereto;
- C. Network Rail wishes to close the Level Crossing situated within Network Rail's Land and which gives access to and from those parts of the Lands lying on either side of Network Rail's Land; and
- D. The Land Owners have agreed to Network Rail's closure of the Level Crossing and to the renunciation and discharge of their rights of access and others over Network Rail's Land by way of the Level Crossing and that on certain terms and conditions to which Network Rail has agreed,
  - NOW THEREFORE the Land Owners and Network Rail Do Hereby AGREE as follows:
- The Land Owners as from and after the last date of signing of this Discharge Agreement and for all time coming renounce and discharge all rights of access, egress and passage by way of the Level Crossing whether by vehicles, pedestrians or otherwise howsoever, being all such rights in

respect of which the Lands may benefit whether granted or reserved by title deed or other instrument or established by prescriptive use or by statute or howsoever otherwise created, and the Land Owners hereby disburden Network Rail's Land of all such rights and others and discharge Network Rail absolutely of and from any obligation to provide any replacement or other such rights whether to be exercised or exercisable by the Land Owners or any third parties under or by the authority of, or deriving right from, the Land Owners.

- 2. The Land Owners warrant and declare that neither they nor their predecessors in title have granted any rights of access or others to any third parties in respect of the Level Crossing and are not aware of any other parties having any rights to use Level Crossing for any purpose.
- The Land Owners and Network Rail shall each be responsible for their own legal fees and outlays in relation to this transaction.
- 4. The Land Owners and Network Rail consent to the registration hereof for preservation and execution: IN WITNESS WHEREOF these presents comprising this and the preceding page together with the Schedule and Plans annexed, are subscribed as follows:
