

Why this project is required

Glenfarg Water Treatment Works (WTW) is located at East Blair and supplies over 179,000 customers across Kinross-shire and central Fife. We are increasing the drinking water storage capacity at the site and improving security of supply for customers in the area it serves.

The planned work will also improve the consistency and quality of the drinking water supplied to customers, including by ensuring a more stable treatment process and flow through the local water network.








Scope of main project

The proposed scope of works and site layout of the additional plant and infrastructure at Glenfarg Water Treatment Works.



The scope of works for this project includes the following:

- 4 new clear water tanks
- new chlorine contact tank
- new pumping station
- new backwash tank
- upgrade and replacement of chemical dosing equipment, filter upgrades

Subject to planning consent, work is expected to start in Summer 2023 and last for approximately 3 years.




Scope of air curtain project

A related, separate piece of work is also planned to provide a permanent Air Curtain Building to replace the temporary arrangement that is currently used. It is hoped this work will be able to go ahead before the main project begins to deliver initial improvement in advance of the larger planned investment.

The air curtain plays an important role in improving the quality of the 'raw' water drawn from the reservoir, upstream of Glenfarg Water Treatment Works. This project will involve the installation of air curtain blowers, compressors and a switchboard within a relatively small purpose-built modular building. This work would be carried out by RSE (Ross-shire





Subject to planning consent, work is expected to start in Spring 2023 and last for approximately 3 months.






Scope of works at existing WTW

Some improvements are also needed to plant at the existing WTW in advance of the larger proposed construction project.





Scope includes:

- Conversion of 8 Rapid Gravity Filters (RGF) from level control to flow control
- Steelwork modifications to improve access to RGFs inside existing building
- Frost protection of exposed RGF pipework
- 1 new Powder Activated Carbon (PAC) dosing plant with control kiosk
- Decommissioning of existing PAC dosing equipment

Planning consent for these works are currently being discussed with the planning authority and then subject to planning conditions works are likely to commence early 2023 and last for approximately 6 months.




The drawings below provide an indication of how the upgraded water treatment works will look

Red squirrels and Beavers are known to be present in the vicinity of the existing works.

An Environmental Risk and Action Plan will be produced and will detail all risk and mitigation measures.

Ecological surveys will be carried out as part of the project.



Traffic Management at Glenfarg

Various traffic management measures are being investigated by ESD:

- 1. Engaging a logistics manager
- 2. Development of a holding area for escorting HGV deliveries
- 3. Implementing managed parking restrictions within Glenfarg
- 4. Improving passing places along the access road
- 5. Surfacing improvements
- 6. Verge improvements including betterment for soft verges and potential for vehicle restraint systems
- 7. Vegetation removal and pruning
- 8. Signage improvements
- 9. Measures to mitigate substandard sighting distances
- 10. Winter maintenance

Vehicles & Plant at Glenfarg

Glenfarg WTW is classed as a major project. Due to the size and extent of the works involved and the new infrastructure required, there will be heavy plant and machinery required to carry out the construction works and make deliveries to the site. Examples of the types of vehicles and machinery likely to be attending site would be excavators, dumper trucks, dozers, cranes, low loaders, tippers, telehandlers, road pavers, rollers, generators, fork-lift trucks. Planning and Licensing at Glenfarg

The proposals for the project scope will be subject to a planning consent being granted by Perth & Kinross Council. Early discussions have been held and feedback has been reflected in the most recent solution, including their preferred location.

SEPA have provided feedback and in principle have no objection to the proposed works.

A variation to the existing CAR licence may be required, however, this is to be discussed further with SEPA. They are also interested in the proposals for the new access bridge, and we will work closely with them as the project develops.







