# Scottish Water (Milngavie Waterworks) Byelaws 2015 explained

Milngavie Water Treatment Works provides clear, fresh drinking water to a large number of customers in the Greater Glasgow area, utilising source water from the Loch Lomond and the Trossachs National Park via a system of aqueducts first conceived by the Glasgow Corporation in the 19th Century. This water arrives all the way from Loch Katrine where it is stored at the Milngavie reservoir complex comprising of Craigmaddie and Mugdock reservoirs.

These historic reservoirs are a popular recreational area for the local community and beyond, but also part of the water system. As a result it is vital that Scottish Water is vigilant in protecting this precious resource now and into the future.

Byelaws for the protection against pollution have been in place at the Milngavie reservoirs for many years, enacted by Scottish Water and also our statutory predecessor organisations. The 2015 Byelaws refresh these provisions and will help us to care for this vital resource for the next decade.

## **How do these byelaws affect you?**

These Byelaws place some common sense restrictions on certain activities around the reservoirs. The effect of the Byelaws is to suspend those water-based activities i.e. boating and swimming, which would normally be permitted under the Land Reform Act 2003.

## **Where do these byelaws apply?**

A copy of the Byelaws is detailed in this leaflet, together with a map indicating the area where the restrictions apply.

# The Byelaws

Scottish Water, in exercise of the powers conferred upon them by Sections 71 and 72(3) of the Water (Scotland) Act 1980 and of all other powers enabling them in that behalf, hereby make the following Byelaws:

#### 1. Citation

These Byelaws may be cited as the Scottish Water, Prevention of Water Pollution (Milngavie Waterworks) Byelaws 2015.

#### 2. Contravention of the Byelaws

Any person contravening any of the provisions of these Byelaws shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 5 of the Standard Scale in respect of each offence and in the case of a continuing offence a further fine not exceeding £50 for each day during which the offence continues after conviction thereof.

#### 3. Definitions

In these Byelaws unless the context otherwise requires, the following words and expressions shall have the respective meaning herein assigned to them, that is to say:

“building” means any structure or erection of what kind or nature whatsoever, whether temporary or permanent and every part thereof, including any fixture affixed thereto.

“defined areas” means the areas in which the byelaws shall have effect, identified in accordance with Byelaw 4.

“open aqueduct” means any aqueduct or natural channel with its surface open to the atmosphere by which water is taken by Scottish Water for the purpose of their water undertaking.

“protected water” means any stream, open aqueduct, loch, reservoir or other inland water, whether surface or underground, natural or artificial, situated within the area detailed in Byelaw 4, and includes the channel or bed of any such water which is for the time being dry.

“road” has the meaning given to it by Section 151(1) of the Roads (Scotland) Act 1984 as amended.

## **4. Application**

These Byelaws shall have effect within the areas of land and protected water lying in East Dunbartonshire bounded by the red line on map marked “MAP REFERRED TO IN THE SCOTTISH WATER, PREVENTION OF WATER POLLUTION (MILNGAVIE WATERWORKS) BYELAWS 2015” annexed and signed relative to these Byelaws, a copy of which is deposited in Scottish Water’s Principal Office at Castle House, 6 Castle Drive, Carnegie Campus, Dunfermline, Fife KY11 8GG.

## **5. Prohibition of Urination and Defecation**

No person shall urinate or defecate within the defined area except within a building connected to a public sewer.

## **6. Disposal of Animal Carcasses**

No person shall:

deposit or knowingly permit to be deposited in any protected water a carcass of any animal or any part thereof, or  
knowingly permit the carcass of any animal belonging to him or her or any part of such carcass to remain in the defined areas, or  
bury or burn or knowingly permit to be buried or burned such carcass or any part thereof in the defined areas.

## **7. Prohibition of Cleansing in Protected Water**

No person shall, in any protected water, wash or cleanse or knowingly permit to be washed or cleansed anything likely to pollute such water, including without prejudice to the foregoing generality, any person, animal, vehicle, agricultural implement, clothes, receptacle or utensil.

## **8. Prohibition of Animals in Protected Water**

No person shall permit any dog, horse or other animal in his or her immediate charge, to enter any protected water.

## **9. Prohibition of Swimming, Skating etc**

No person shall, except for the saving of human life, enter in or on any protected water.

## **10. Conduct Within Defined Areas**

Unless with the authority of Scottish Water:

No person shall drive any vehicle within the defined areas except for purposes of access to a dwelling house.

No animal shall be allowed within the defined areas, with the exception of a dog which is kept under the control of its owner or another person having immediate charge of it.

Unless with the authority of Scottish Water, any person within the defined area shall keep to existing roads, paths or public rights of way.

Within the defined areas no person shall:

unless with the authority of Scottish Water obstruct or attempt to obstruct the flow of water in any drain or open aqueduct, or open, shut or otherwise interfere with any sluice-gate or other apparatus belonging to Scottish Water.

## 11. Prohibition of Fishing

No person shall fish the protected water.

## 12. Prohibition of Boating etc.

No boat, vessel or similar apparatus, not being the property of Scottish Water, shall be placed or navigated in the protected water.

## 13. Members etc. of Scottish Water

The foregoing Byelaws shall not apply so as to restrict any member, official or employee of Scottish Water, nor any person or the employee of such person employed by Scottish Water, while acting within the scope of his or her official duties or employment, in or about any work within the defined areas.

## 14. Revocation

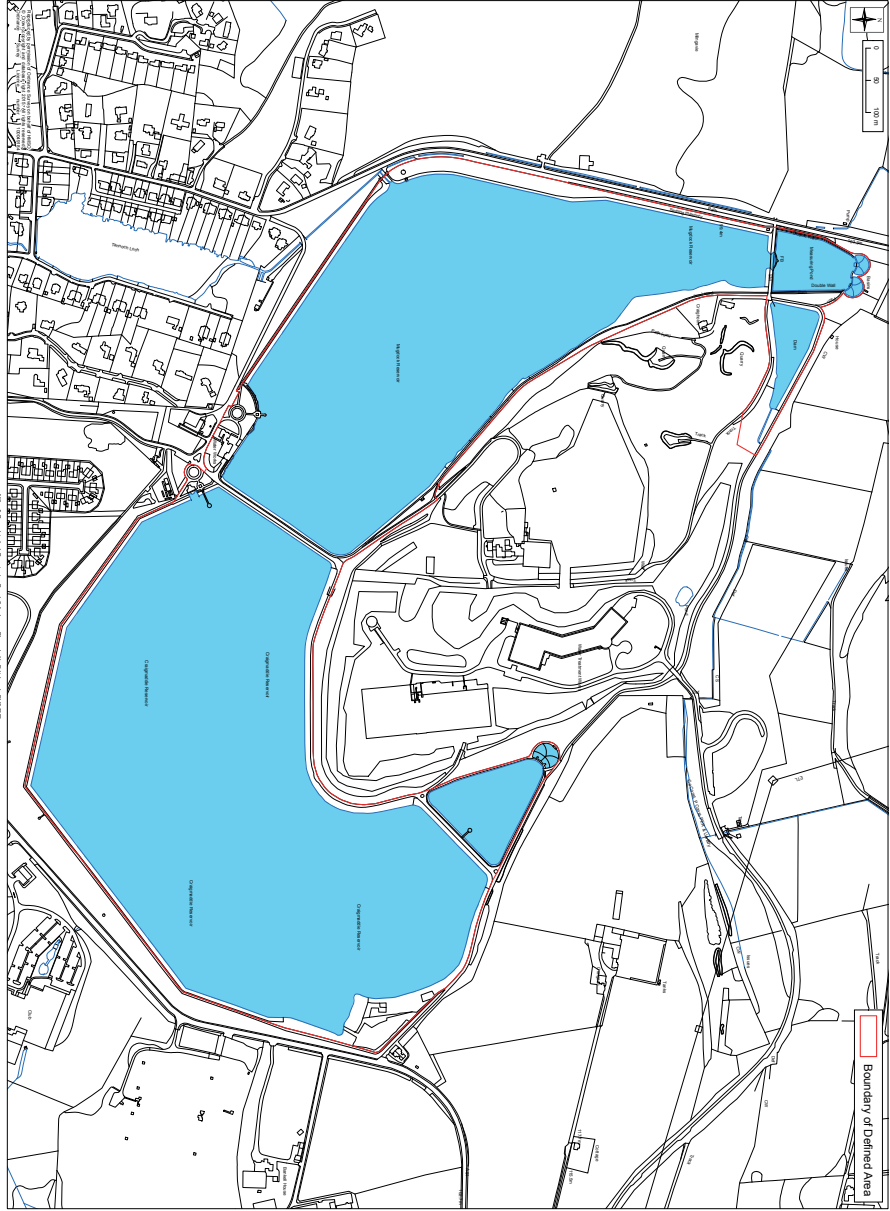
The Milngavie Waterworks Byelaws made by Scottish Water on 2<sup>nd</sup> November 2005 and confirmed by the Scottish Ministers on 30 March 2006 are hereby revoked.

It is hereby certified that the foregoing is a true copy of the byelaws which came into operation on the 16<sup>th</sup> day of November 2015, were made by Scottish Water on the 30<sup>th</sup> day of September 2015, and were confirmed by the Scottish Ministers on the 12<sup>th</sup> day of November 2015 with effect having been given to certain modifications, namely the substitution of the map annexed hereto, made by the Scottish Ministers at the time of confirmation.
